

### Fr. Charles Lasardo SJ, Principal SJCC



A total of 22,60,000 was paid to the college as scholarships.

# FINANCE REPORT FOR ST. JOSEPH'S COLLEGE OF COMMERCE FOR THE FINANCIAL YEAR ENDING 31ST MARCH 2023

---

The financial position of the SJCC is growing from year to year our investments have grown from 2.04 crores to 3.23 crores an increase of 1.19 crores.

During the year we paid out 22,60,000 as scholarships to 140 students in the college. A further 12,12,000 was paid as scholarships to 54 students in the first PUC who are part of the Multi-Batch Scholarship whose education will be funded right through college.

Like last year we asked for ,applications for scholarships, we interviewed the student along with their parents and then allotted the scholarships to needy students. Allotment was done irrespective of caste, creed or religion. We received 146 applications we shortlisted 146 applications 145 came for the interview and allotted 140 scholarships. The short list were from families earning less that Rs.10,000/- per month. The people we met were drivers, maids, tailors most of whom were non-catholic. We paid out roughly 16,000 per student and we hope that in the future we will be able to increase this amount.

We did a training programme for 60 less fortunate students in the final year to equip them to get a job after their graduation. The cost of the course worked out to Rs.2,50,000/- An advance of Rs.1,00,000/- was given in the last financial year and the balance paid in this financial year. Mr. Dilip Surana who set up a corpus fund of 25 lakhs to support this venture has agreed to re-imburse entire expenditure of this course.

We collected a sum of 52,00,000 for Alumni from different batches which will be used to fund the education of students right through college. 12,00,000 was spent on 54 students this year and the balance will be used to fund their education for the remaining years in college.

The Batch of 1981 collected 14,50,000 in the Scholarship Fund taking the corpus to 17,00,000

The Batch of 1973 added another 10,07,958 to their corpus taking it to 1,10,70,000

The Batch of 1982 opened their Scholarship Fund account with a donation of 14,000

Mohandas Pai donated a sum of Rs.10,00,000 which was totally paid out as scholarships to need cum merit based students.

Srinath Prabhu donated a sum of Rs.1,05,000 which was paid out to 7 girls who were economically not well off.

Manoj Pasangha set up a Corpus Fund of Rs.2,10,000 the interest of which will be used to give a cash prize of

Rs.10,000 for the best class in Kalotsav (Inter Class Cultural Competition)

A sum of 1,06,900 was spent on the Teachers Day celebrations

A sum of Rs.1,50,000 was given to the college for Teacher Training and Bonding

Awards were given to the Best Outgoing student and for Leadership. All the Inter Batch Sporting Events were underwritten by the OSA

We wish to thank our Principal Rev. Fr.Charles Lasardo for the full hearted support given to the OSA during the year. A big Thank you to the staff of the college and the College union who helped in most of our activities and last but not the least I thank our Managing Committee who worked as a team in all the activities of the OSA

### 1 Statement of Significant Accounting Policies

- i) Generally, all income and expenditure are accounted on a cash basis.

- iii) Out of the contribution from 2021-22 batch of of Rs. 4,73,500/-from the college  
50% has been capitalised and 50% has been taken in P&L a/c
- iv) The total collection of Patron Membership amounting to Rs.15,000/- has been capitalised
- v) A sum to Rs.150,000/- was paid to the college towards a program conducted for the staff by the college
- vi) A sum of Rs.1,00,000/- was paid towards the Skills Development Program for needy students
- vii) There was a deficit of 1,06,905/- in the teacher day celebrations organised by th Alumni Association.
