OSA WEBSITE & ONLINE STORE

The SJCC OSA website was launched and is a platform for past students to connect with the OSA. Additionally, the online store has been launched in partnership with yourdesignstore.in. Proceeds from sales through this store will be used to provide financial assistance to deserving students of SJCC as academic scholarships. We thank Zubin Unavalla our council member for putting in his sincere efforts and time to ensure the website is up, running, interesting and efficient. We thank the College staff and management, the student council and our own team for coming forward and helping us achieve so much.

OSA SKILL DEVELOPMENT PROGRAM

Pleased to inform you all that this year the OSA introduced the first program on Tally/ GST/Communication for final year B'com students. A Skill Development training consisting of 40 hrs on tally and basics of GST AND 16 hours on communication and presentation skills for students who are from basically very poor economic background . 25 students benefited from this program. FINANCE REPORT FOR ST. JOSEPH'S COLLEGE OF COMMERCE FOR THE FINANCIAL YEAR ENDING 31ST MARCH 2020

I would like to start by first making a small correction in the accounts. Looking at Scholarships in the Schedules we find that, the General Scholarship account shows an amount of Rs.2,60,000/- this figure includes an amount of Rs.1,25,000/- given by the batch of 1991 who now want this amount to be shown separately, which will be done, hence the batch of 1991 scholarship fund stands at Rs.1,25,000/- and the General Scholarship Fund stands at Rs.1,35,000/- Looking at the Balance Sheet we see that the total Scholarship Fund increased by Rs.4,00,000/- this was due to an increase in the Class of 1973 Scholarship Fund. The Awards and Training Fund increased by 9,35,000/-mainly due to a new fund set up this year called the Skills Development Fund and the Devaraj Chordia Charitable Fund. These funds provide skills training to less fortunate students in the college. We are proud to say that the program which was co-ordinated by our Vice President Mr. Chetan Venugopal was a huge success. On the Assets side we see that our Investments increased by 15,27,000/- from 1,42,44,000/- to 1,57,71,000.

During the year we paid out 8,70,000 as scholarships to around 85 students. For the first time the OSA asked for applications for scholarships, we interviewed the student along with their parents and then allotted the scholarships to needy students. Allotment was done irrespective of caste, creed or religion. I wish to state that there is a lot of need in this area. We received over 200 applications we shortlisted 100 applications and allotted 85. The short list were from families earning less that Rs.10,000/- per month. The people we met were drivers, maids, tailors most of whom were non-catholic, we asked them how they managed to get admission in SJCC they being students from none of the prestigious schools, they told us it was God and Fr. Principal who made it possible. I wish to congratulate our Principal Fr. Daniel Fernandes for opening our college to the less fortunate as well. Thank you Fr. Daniel We the Alumni Association makes a request to individuals, batches, etc. to support these less fortunate students there were a lot more who needed money and we had to reject their applications due to lack of funds, further we paid out a mere Rs.10,000/- when the fees are around 70,000 for some courses and a lakh plus for other courses. I humble request our Alumni to please set up scholarship funds to support the needy in our college.

We also did a training programme for the less fortunate students in the final year to equip them to get a job after their graduation. We started the fund this year and a pleased to inform you that we collected a sum of Rs.8,00,000/-. The cost of the course worked out to Rs.1,20,000/- The students found this course very useful and if we are to continue this course in the future we will need a lot more money in the corpus to fund the training. I again urgently appeal to alumni to be generous. This year for the first time we conducted a Photography workshop for our students and thanks to Anup Kattukaran we were able to earn a sum of Rs.27,400/- We conducted a number of other activities which was reported by our Secretary. I wish to thank our Principal Rev. Fr. Daniel Fernandes for the full hearted support given to the OSA. Thank you to the staff and College union who helped in our activities and last but not the least I thank our Managing Committee who worked as a team in all the activities of the OSA

This citation is presented to Salil Rajshekar Shetty for his fierce determination and courage to stand up for the economic, civil, political and human rights of millions of dispossessed people around the world.

A long-term activist on poverty, inequality and injustice, Salil led Amnesty International's worldwide work from 2010 to 2018 to end human rights violations and spearheaded the bold and significant move of Amnesty International's work to the global south.

As Director of the United Nations Millennium Development Campaign between 2003 and 2010, Salil was credited with significantly increasing awareness and holding governments accountable for the Millennium Development Goals worldwide.

Salil has worked alongside, supported and upheld the cause of dispossessed communities around the world. He has spoken about and raised awareness of these issues on major international TV channels and print media. Salil created history when he was the only civil society leader invited to speak to the Heads of State at the UN General Assembly in 2015.

As Chief Executive of Action Aid, a leading international NGO, from 1998 to 2003, Salil took some path-breaking decisions to give power back to communities in the global south.

Salil Shetty's core values mirror those of the Jesuit educational institutions which shaped his youth – St. Joseph's Indian High School and St. Joseph's College of Commerce.

Salil completed his MBA degree from the Indian Institute of Management, Ahmedabad. He was awarded the The Titmuss PhD Prize, a prestigious award, presented annually, to recognise the most outstanding thesis, at the London School of Economics where he secured a Masters in Social Policy and Planning.

On this day, the 27th of November, 2019, this Citation is awarded to Rahul Sharad Dravid for his contribution to the game of cricket and for bringing honour and pride to his Country, State, Community and College.

Rahul's achievements as the Indian cricket team Captain are outstanding. He made history by leading India to their first Test victory in South Africa. He was the first in 35 years to lead India to a series victory in the West Indies and the first in 21 years in England. As skipper, he created a world record of 17 successful run chases in ODIs. He led India proudly and with great distinction in 25 Tests and 79 ODIs, tasting victory in 8 Tests and 42 ODIs.

Rahul's outstanding batting displays in the face of great adversity and on challenging pitches overseas gave him the sobriquet, "The Wall". He was the pillar of the best batting unit in the world.

His record of 13,288 Test runs in 164 Tests at 52.31; 10,889 runs in 344 ODIs at 39.16; 36 Test hundreds and 63 fifties; 12 ODI hundreds and 83 fifties made him one of the world's best batsmen and he finished as the fourth highest Test rungetter of all time.

Following his playing career, Rahul has been a coach of the India A and India under 19 teams – coaching India to victory in 2018. He currently serves as the Head of Cricket at the National Cricket Academy. The future of Indian cricket is truly in safe hands.

His exemplary conduct and the impeccable way he has carried himself on and off the field are a tribute to the values that the great institution of St. Joseph's College of Commerce holds dear.

Dilshad has worked in the media and entertainment space for over 22 years and has several television channel launches to her credit. After completing her Masters in Telecommunication Management from Michigan State University, Dilshad returned to India to work with STAR TV, where she led the launches of Zee Cinema, STAR Plus Hindi, STAR News, and was responsible for the STAR brand launch in the UK.

As Senior Vice President of National Geographic Channel heading Programming and Marketing, Dilshad introduced Indian content internationally, creating some of the channel's most iconic shows – Mission Everest and Mission Udaan. Here she tied up with the Indian Army and the Indian Air Force respectively, bringing an insider's view into India's armed forces. Under Dilshad's leadership, The History Channel was also launched in India and she guided it's Indianization to ensure its appeal to Indian audiences.

Dilshad's last held responsibility in the broadcasting space was as Chief Operating Officer of UTV Entertainment, where she launched two more channels – bringing it to a total of seven television channels in India - an incomparable feat that has probably remained unmatched till date.

Dilshad moved out of the broadcasting space to explore her next big passion - adventure travel. Today, she sits on the board of Outward Bound India - Himalaya, an international organization that provides life skills by experiential training in the outdoors. The main aim of the program is to get people out of their comfort zones to explore their true potential.

As an adventurer and explorer, Dilshad has led several treks in Nepal and India (including Mount Everest Base Camp), tackled Grade 5 rapids on the wild Zanskar river in Ladakh, and is the first and only female to ever lead a civilian trek to the Siachen Glacier – all of this after surviving cancer.

Dilshad is also a motivational speaker and speaks on topics closest to her heart. She focuses on urging children and professionals to go into the wilderness to understand leadership and responsibility, teamwork and personal growth, aspirations and ambitions.
